

## Eligible legal forms of applicants

#### Public authorities (Public)

- National, regional, or local authorities special competencies and tasks in public interest
- State-owned companies having portfolio according to national legislation
- Asset management foundation established by the state.

#### Public bodies governed by public law (Public)

Bodies that are established for the specific purpose of meeting needs in the general interest, financed, for the most part, by the state, regional or local authorities.







# Eligible legal forms of applicants

#### Non-profit organisations governed by private law (Private)

Bodies that have no industrial or commercial character and are not financed, for the most part, by the state, regional or local authorities

#### Small and medium sized enterprises (Private)

Any entity engaged in an economic activity, irrespective of its legal form. This includes, in particular, self-employed persons and family businesses, and partnerships or associations regularly engaged in an economic activity.



# Partnership requirements

#### Joint development

The project idea must be jointly developed. Partner declaration must be submitted by each Partner.

## Joint implementation

Each Partner must be responsible for at least one core activity.

#### Joint staff

Each Partner must involve its own employees into the project implementation.

## Joint financing

At least one Partner from each member state is financed by the programme.





# Lead Partner principle

#### Legal aspects

- Bears legal responsibility for the implementation of the entire project
- Lays down the arrangements with the other partners
- Signs the subsidy contract with the Managing Authority in English

#### Main tasks

- Submits the Application form
- Submits the project and follow-up reports
- Transfers the reimbursed ERDF contribution to all other partners

# Eligible expenditures

- Full day event 47€/person
